May God continue to be glorified, through the people who have been involved in the preparations for the **upcoming Christmas Concert, on Friday, December 5, at 7pm**. We ask for your prayers that God will use us to convey a message of hope to the audience, through the Gospel to be shared in the songs, readings, and a brief meditation. a town 31 km from here. He is not a believer, he studies guitar at a conservatory in a nearby town, and he has handled sound for important events a few times. He has his own equipment at home with which he makes small, limited recordings, and he agreed to help us. Interestingly, his father painted our church building here in Peñarroya years ago.

Hugo has brought up the subject of "Protestant Christianity" (*our category*) on his own, and we have agreed to talk about it, as he is very eager and open. Danny will continue to help Hugo with his recording goals here, at home, thereby fostering a closer relationship, with the hope that Hugo will come to accept the Gospel.

We are considering broadcasting this event online, most likely via Facebook or YouTube. We will notify you once a decision has been made.

We thank God for allowing the women's group to grow. On Wednesday night, November 27, we started a **second discipleship group** with a group of very enthusiastic girls.

Please pray hard for **Aurelia**, a Romanian who struggles to understand Spanish, and for **Antonella**, a Catholic who is searching for the Way, the Truth, and the Life.

We also started **the first discipleship group for men**. We also ask for your prayers for **Javier**, a young Spanish believer, with South American parents, who recently came to church one Sunday and decided to stay. He is new in the faith, but eager to grow. We trust that God will allow us to see results.



We praise God for sustaining **Melody** at the Seminary. Although her health issues add to her academic and ministerial workload, we trust that the Lord will fulfill His purposes for her. Thank you for praying that the Christmas holiday break will allow her to improve her health. She will stay on

campus to work until her classes resume in January 2026, at which point she will begin the final stage of her studies.



We praise the Lord for His mercy and faithfulness in the lives of our children **Sammy** and **Lara**.

Thank you for praying for their marriage, ministry, and work.

We praise the Lord for finally providing Sister **Yessenia** with a job at the home of **Danny's father, Itiel**, and his sister and brother-in-law.
